CURRICULUM

SESSION ONE: HARNESS YOUR LEADERSHIP STYLE

In this workshop participants will explore the five practices of Values Based Leadership – Build Awareness, Realize Potential, Develop Relationships, Take Action, and Practice Reflection – and identify the core values and beliefs that influence their behaviors, decisions, relationships, and ultimately effectiveness. This session includes the personality instrument Insights ® Discovery – a tool that helps participants to identify their personal style and that of others. Participants will explore personality style as a key leadership tool – learning communication preferences and how to connect and inspire others through their unique leadership vision to achieve desired outcomes.

SESSION TWO: BUILDING YOUR LEADERSHIP TEAM

In this workshop, participants will learn how to approach team development in a holistic and inclusive manner. This workshop will help leaders identify how to assemble, structure, and ultimately manage teams to their highest levels of potential while exploring and analyzing family business continuity challenges and best practices for successfully leading family-owned businesses.

SESSION THREE: DEVELOPING AN EFFECTIVE BOARD

In this workshop, participants will explore how to develop a Board that is prepared to effectively help facilitate transitions, clarify issues, assure proper management planning, foster sharing of information, and provide stability and continuity during times of change. Participants will identify short and long-term areas for improvement and how to provide support and structure to ensure the Board's expertise, experience, and compensation is aligned with their strategy and goals.

SESSION FOUR: IGNIGHTING INNOVATION

In this workshop, participants will learn how to reignite the spirit of innovation upon which their family business was founded upon in the first place. They will explore the idea that adaptability is key to innovation and learn how to respond flexibly and creatively to constantly changing, and oftentimes unpredictable, environments by cultivating a family enterprise mindset. Participants will then assess their family enterprise's strengths, weaknesses, opportunities, and threats, as well as synthesize market trends and customer data to begin developing a plan that will deliver value for all stakeholders.

SESSION FIVE: IMPLEMENTING VALUES AND CULTURE

In this final workshop, participants will explore their role in leading and enabling their family and family business's culture in alignment with strategy to achieve desired outcomes. They will build an engagement roadmap for the future using the Five Practices of Values-Based Families: Celebrate Legacy, Include Everyone, Build Unity, Envision the Future, and Sustain Connection. Participants will also present their personal leadership visions (that they will have been working on with their coaches throughout the program) and how they are putting their visions into action.

COACHING & FACILITATORS

INDIVIDUAL COACHING

This is a five-month program that features five half-day in-person workshops also includes one-hour individual coaching sessions beginning in August 2023.

Before the program, each participant will be matched with a certified coach. Between each workshop, the certified coach will meet with the leader virtually to identify goals, practice new skills, gather feedback, and make choices that align with values to bring about individual and organizational success. The coach will work with the leader to develop an Individual Leadership Development Plan enabling each leader to continue their leadership journey well-beyond the end of the program

FACILTIATORS

The program will be facilitated by InnerWill Leadership Institute and Family Business Consulting Group.
